QUEN – Torture Breeding Evidence Network



The **torture breeding evidence network (QUEN)** is a non-profit organisation founded in 2021 crossing borders with a concentrated **network of experts** from the fields of veterinary medicine, biology, genetics, law and animal welfare making their knowledge regarding breed deformities caused by breeding (torture breeding) available to all.

The legal entity is the non-profit limited company „**Qualzucht-Evidenz Netzwerk (QUEN) gGmbH**“ with its registered office located in Himmelpforten, Germany.

The nub of numerous projects is the development of the **QUEN database**, which aims to support veterinary authorities, courts and political decision makers effectively, as well as vets and breeders to implement animal protection law abiding standards.

Where is QUEN heading ?

1. Development of the **QUEN database** and expansion of the **fact sheets** regarding the specific deformities caused by torture breeding making current animal welfare laws easier to understand.
2. The further development of **DiaQUEN** in order **to categorise strains on health** (taking a leaf out of Holland's and Switzerland's book) allowing an objective evaluation of the health strains on animals caused by breeding.
3. The provision of easily accessible and free **advice for veterinary inspection offices** with the aim of reducing the workload of the enforcement authorities and in so doing reduce the deficits in official animal welfare and to implement the animal welfare national objective effectively (Art 20a GG)
4. To make a contribution to the **harmonisation of international animal welfare standards** providing cross-border, standardised frameworks for breeding, showing and trading with animals.

Database

The QUEN database provides a consecutive, amended number of evidence based, structured **sources of information**, which are subject to strict quality management by the scientific advisory board and are **recognised by the courts as expert opinions**.

The data and information are updated continually in accordance with current scientific information.

Main focus | Digital content

- Collecting **scientific knowledge** regarding breeding related deformities, predisposition and illnesses
- **Fact sheets** about the deformities of different kinds of animals and breeds
- **Legal foundations**, current verdicts and specific examples
- Access to **reports and literature** for vets, veterinary inspection offices, political decision makers and the interested public
- Professional exchange with scientific institutions

Fact sheets

The **fact sheets with the specific deformities** caused by torture breeding will be compiled for animals and breeds sporadically.

Structure

- Description of the deformities/breeds
- Possible problems/syndromes
- Symptoms and prognostic value
- Physical/psychological strains
- Inheritance, genetics, known genetic testing, if applicable
- Diagnosis
- Animal welfare evaluation (DE/AT/CH)
- Verdicts / references (international)
- Necessary and possible regulations from a veterinary perspective

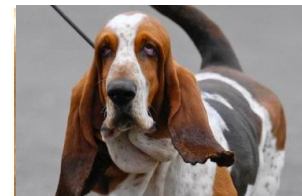

DiaQUEN - Project



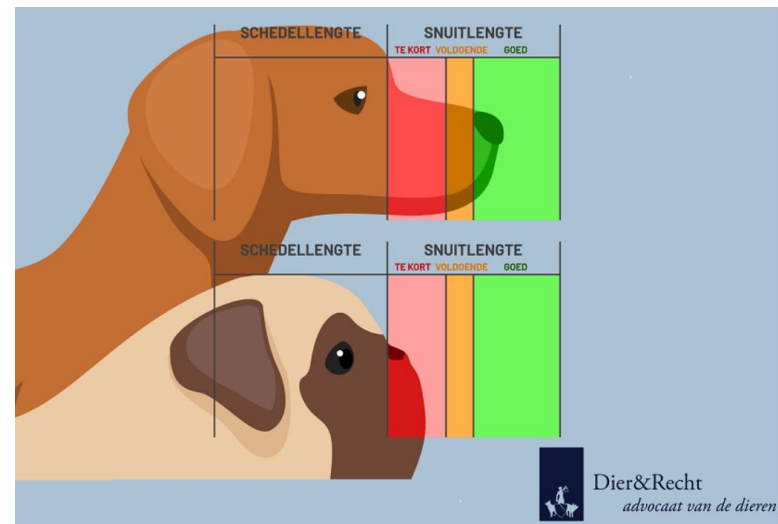
Web application

The web based application **DiaQUEN** should make a neutral, cross-border and objective evaluation of strains caused by breeding in animals used for breeding.

The aim is to prepare **a tool to judge the suitability for breeding and showing.**

The current project DiaQUEN, which is still being developed is being realised in cooperation with the authorities from different countries. It is based on the traffic light system for brachycephalic dogs from Holland, as well as the Swiss evaluation model.

Stress categories from 0 to 3 provide a classification of breeding related deformities of all kinds of animals.

QUEN-Advice



Advice

QUEN runs a nationwide **advice service for veterinary inspection offices** and education of the public regarding possible breeding deformities in all kinds of animals and breeds.

The aim is to advise and support vets, veterinary authorities, political decision makers and the interested public in the implementation of current legal standards in the field of torture breeding in a practical and evidence based manner that is legally watertight.

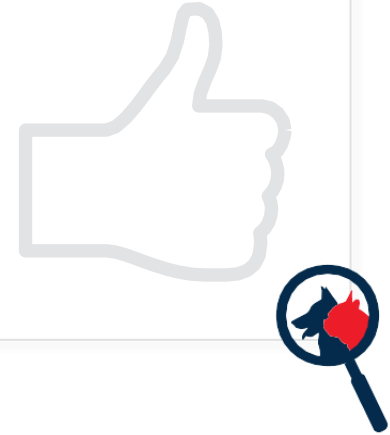
Main focus

1. Specialist advice regarding breeding related deformities
2. Support and consultation in questions regarding verification and enforcement questions
 - Model requirements for showing
 - Support in the formulation of authoritative measures
 - Provision of legal reports and jurisdiction
3. Digital service platform
 - Online knowledge database, email support
 - Tools for case evaluation (e.g. checklists)
4. Building networks
 - Cooperation with universities, trade associations and NGOs
 - Promoting scientific publications and dissertations
 - Sharing experiences cross-border and regardless of departmental boundaries



QUEN – Successes

What has QUEN achieved until now?



1. Project manageress received the **animal welfare award 2023** of Lower Saxony, Germany
2. Until now **over 50 fact sheets** have been prepared; 46 of those have been published (status as of May 2025)
3. Homepage access: serious **visitors 2,000 per month**
4. Advice: **3-5 consult enquiries** from veterinary inspection offices **weekly**
5. Fact sheets **recognised by the courts as expert reports** e.g.
 - Administrative court in Stade – Ref. 11 ME 221/22 (resolution from 25.10.2022), *breeding ban for French and English bulldogs*
 - Administrative court Düsseldorf – Ref. 23 K 7084/22 (verdict from 05.11.2024), *showing ban for dogs with deformities caused by torture breeding*
 - State administrative court Vienna, LVwG Wien VGW-001/024/12790/2024-8 of 27.01.2025, *breeding ban for short nosed and short headed cats (here: Persian cat, Peke-face type)*
6. Project related support and donations from individual ministries, state animal welfare officers and animal welfare organisations
7. Recommendation by the BMEL and the Federal Chamber of Veterinarians
